IV. Old Business

a. Safety Railings in the Stairwells:

We will have Paul walk the community and note the ones he can paint and the ones that need to be replaced because they will not hold the paint anymore. I would like the Board to consider the possibility of getting the railings replaced

- b. Water Shutoff Valve & weather monitor
 If these are still not working this year the board has given WEB the approval to
 get them replaced right away.
- c. Landscaping Project:

There is no approved project set for this year. If we want to get the Flag pole area done we will need to choose a company to do so and get them working on it. Bridgett will set up a time to walk with the new company owner and make sure of the scope of work as well as recommendations and a bid.

d. Camera's for Community:

The majority of the home owners are for these being put in. We may want to have a professional company give us a quote on what they believe should be installed and where so that we know if we are actually getting enough coverage and quality before we look at this project. We will put this on hold until we are sure of the pricing to finish up the landscaping.

e. Mansard Project:

Now that we have no more snow and things should be drying out I will be getting quotes for this project. Our maintenance staff can't do the painting. They may be able to do the replacement of boards for the HOA but that would be it.

V. New Business

- a. Replacement of Board members2 spots available volunteers were asked for.
- b. No Smoking signs up in common areas Leslie requested that we put up no smoking signs, mettle ones and no trespassing signs on the common area decks and pool area so that if people were breaking the quite hours that did not belong on the property they could be trespassed. The Board approved having Paul do this work.
- c. Light for the monument sign
 Leslie asked that we put in lights at the monument sign. They can be light
 sensitive and plugged into the back of the sign. The Board approved having Paul
 do this work.

Several home owners voiced concerns that the lighting was older and fixtures might be going out. They also wanted to possibly change the light bulbs to LED to save on energy in the long run.

A homeowner recommended having a landscape clean-up day for the flower beds and bush area to bring up community involvement.
